-NYSERDA Grant - \$68,000 (Comp. Plan): Public meeting was held on 9/27/17.

-NYS WIIA Grant - \$3,000,000 (WTP Upgrade Project): New grant awarded to Village. Details to be received on 10/11/17.

- -NYS-DOS Grant \$145,000 (Canal to Downtown): Substantially completed.
- -NYS-Canal Corp. Grant \$145,000 (Canal to Downtown): Substantially completed.
- -NYS-DOT(CHIPs) \$242,876.15 (Stark Street): Substantially completed.
- ESD (Pump Station Upgrade) \$600,000 Station was installed on 9/14/17.

Total grant funding to the Village is now \$10,553,000 in 14 active projects.

Motion by Trustee Mull, seconded by Trustee Suffredini to approve the resolution allowing the Village to participate in the 2017 Justice Court Assistance Program (JCAP). All voted aye, carried.

Motion by Trustee Suffredini, seconded by Trustee Mull to approve the audit review letter from Paul Wagner, Municipal Financial Consultant, for the review of the financial data and records of the Village of Waterloo for the Fiscal Year ended 5/31/17 stating that there were no findings requiring written disclosure. All voted aye, carried.

Motion by Trustee Mull, seconded by Trustee Suffredini to approve the request from the WVFD to hold its annual Turkey Party on Friday, November 17, 2017 during which beer will be served with proper permits. All voted aye, carried.

Motion by Trustee Mull, seconded by Trustee Marquart to approve the temporary appointment of Matt Millis by Fire Chief, Mike Reese, to the position of Lieutenant for the WVFD until the elections are held in April, 2018. All voted aye, carried.

Motion by Trustee Mull, seconded by Trustee Marquart to approve Phase 1 of the signage program (NRHD Streetscape Enhancements) developed by the IIP Team at a cost of \$14,400, as part of the NY Main Street Grant Program. All voted aye, carried.

Motion by Trustee Mull, seconded by Trustee Suffredini to adjourn meeting. All voted aye, carried. Meeting adjourned at 7:37pm.
